Exposure Visit of CBSE School Principals to Organizations/ Institutions of Eminence in India

The National Education Policy 2020 has emphasized that Skill Education will be integral to School and Higher Education. Accordingly, CBSE has envisioned promoting Skill Education from Class 6th onwards in all its affiliated schools.

In continuation of CBSE notification dated 26.03.2024, the Board has planned to organise more exposure Visits to various Organisations/ Institutions of eminence in India. Further, with the support of senior faculty members of such institutions capacity building of school leaders has been planned. The Exposure Visit of Principals will help to leverage the synergies between schools and Higher Educational Institutions and create a positive platform for cohesive interaction in the future learning ecosystem. A series of Exposure Visits with various HEIs are scheduled from May 2024 onwards.
